CURRENCY EXCHANGE ZONING CHANGE UPDATE

The Currency Exchange known as “9439 S. State Street Building Corporation” Purchased 28 E. 95th and 30 E.95th in 2014. On September 11, 2015 they applied for a change in zoning for this land from RS-3 to C1-1

The 94 and Wabash, 94th and Michigan Ave, and 95th Street from Wabash to Michigan organized a coalition against the zoning change and went to City Council to testify in front of the “The Committee on Zoning. Landmark and Buildings Standards” Chaired by Alderman Daniel Solis. **The hearing and vote on this matter has been rescheduled to November 17th.**
